The IRS has published a chart on ACA Form deadlines to assist you with understanding the new deadlines due to the recent extensions.

As with 2015 tax filings, individuals will be able to file their federal income tax return if they haven't received their Form 1095 by the time they are ready to file.



The IRS has issued a reminder to help taxpayers avoid tax scams related to identity theft and refund fraud including fake emails, robo-calls or bogus calls from the IRS, and phishing schemes to company Payroll and HR Departments.



The SSA will suspend mailings of paper Social Security Statements to workers under the age of 60. They will continue mailing Statements to those 60 and over who do not have a my Social Security online


account and are not receiving Social Security benefits

New Revised I-9 Form

By Jan. 22, 2017, employers must use only the <u>new</u> revised I-9 version, dated 11/14/2016. Until then, they can continue to use the version dated 03/08/2013 or the new version.

2017 Officer Nominations



We are accepting nominations for President Elect and one Board Member through the March meeting. We will then vote electronically and the new officers will be announced at the April meeting. Please be sure to speak with your nominee before submitting their name as a nomination. The nominations should be submitted to our <u>President</u>, <u>Ansleigh Smith</u>, <u>CPP</u>.

Below are the duties of each of the two positions that are open for 2017 nominations.

President Elect

The President Elect shall be an active member in good standing with the National APA and the Atlanta Chapter of the APA. The President Elect position's intent is preparation to be President. Responsibility may include but not limited to:

- In absence of the President, the President Elect shall preside over Member and Officer/Board meetings.
- The President Elect will fill in for any absence of other officers during Chapter meetings, Officer/Board meetings, and any other duties as the Board may prescribe.
- The President Elect will automatically advance to the position of President after a one year term.

Board Member

The Board of Directors shall be active members in good standing with the National APA and the Atlanta Chapter of the APA. Responsibility may include but not limited to:

- The Board of Directors shall have supervision, control, and direction of the affairs of the Chapter.
- The Board of Directors will determine its policies or changes therein within the limits of the Bylaws.
- The Board of Directors will have discretion in the disbursement of Chapter funds.
- The Board of Directors may adopt rules and regulations for the conduct of its business as shall be deemed advisable, and may, in the execution of the powers granted, appoint such agents as it may consider necessary.

Volunteering

Our Chapter has several committees for members to be a part of. This is a wonderful opportunity to volunteer your time and skills to benefit the Chapter. The committees are made up of a Committee Chairperson that is determined by the President and the Board of Directors (must be a National APA member) and Committee Members. The Committee Members are volunteers who are active members in good standing with the Atlanta Chapter of the APA and must attend 50% of the monthly chapter meetings.
