Have you received a failure to deposit penalty notice from the IRS for first quarter? You may not be alone. Due to the Emancipation Day holiday tax deposits weren't due until April 18<sup>th</sup>. However, a computer error resulted in deposits made after April 15<sup>th</sup>, the normal due date, being marked late.

The IRS should send follow up notices that the penalty will be waived.

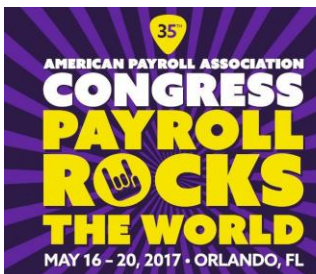

Habitat for Humanity is quite a large organization and there are several different offices servicing this wonderful organization in the state of Georgia. In the past we have worked on a build with the Atlanta HFH office but for this spotlight I would like to focus on the Habitat for Humanity – North Central Office. Their Vision is: A world where everyone has a decent place to live.

Habitat for Humanity builds homes with the help of volunteers, sponsors and donations for those who are need of housing but do not have the means to hire a realtor and just purchase a house. Families are chosen through a careful screening process to be able to participate in this home ownership program. They are required to make payments on the home as they would any other type of mortgage but the costs are lower because the home is built by volunteers and the materials have been donated.

There are several builds (or sites) around the north central Georgia area where volunteers are needed. When volunteers are needed an email is sent out to those who have expressed an interest in volunteering. From that email you simply click on the link and all of the information is on the page it connects you to such as the location, date and time of the build.

Also if it's a specific type build, such as painting or woman's build, that will be stated as well. From this page you will also sign up to volunteer for that build. It's that simple. Let's, review... 1 - receive email, 2 - click on link in email, 3 - read location, date and time of build, 4 - sign up to volunteer, 5 - show up to the location at the time and date that you have signed up for and 6 – take pictures of you and your group volunteering and enjoying giving back to the community.



Easy peasy, and you have now volunteered for a build with Habitat for Humanity. So next time you see that email about volunteer's needed, click on it and volunteer and donate a little of your time. You will be glad you did. 😊
